Certification of organic farming in Latvia

Any operator who manufactures, prepares, stores, imports from third countries or places on the market the following products, before placing any product on the market as an organic or conversion transitional product:

- Submit an application for certification to the control body
- The operator is included in the control system

Production

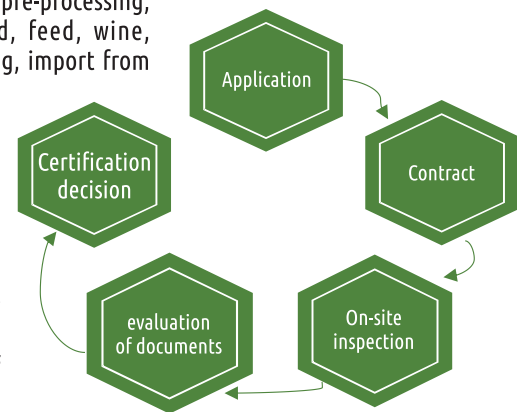
Areas of product categories: plants products, livestock products, algae and unprocessed aquaculture products, non-traditional livestock products, wild plant products

Processing

Processing certification covers all stages: pre-processing, packaging, storage, processing, (food, feed, wine, beeswax, yeast etc.), marketing, catering, import from third countries.

New! Operator group certification **APPLICATION** for certification for processing all year round, in production at least one month before the start of operations!

International cooperation

- Non-EU operators who produce, handle or process organic products and wish to trade them in the European Union with reference to organic farming must be included in the control system for organic farming. STC performs certification according to the STC “Production standard and control measures” equivalent standard of organic farming in third countries.
- Certification according to the **BeVeg vegan** standard - Food, textiles, cosmetics, medicines, etc. for the certification of products that do not contain products of animal origin.
- Sampling and sending to European laboratories for testing both organic and non-organic products. The range of services includes evaluation of test results
- We offer physical control of cargo and sampling during loading of export products both in Latvia and elsewhere in Europe and third countries
- We certify organic production, processing and products according to:
 - China (OFCC), certification to standard requirements GB/T 19630;
 - Taiwan Eco-Garden, certification according to the standard requirements of TOS;
 - Republic of Korea (DCOK) standards

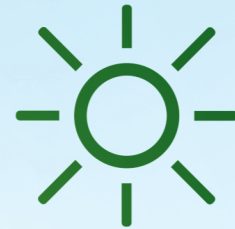
